## OUR INVITED SPEAKERS

**Jeanette Fitzsimons** was an MP from 1996 till 2010, as Green Party Co-leader from 1995 until stepping down in June 2009.

Jeanette has been contributing to the energy debate in New Zealand since the nuclear power controversy of the seventies and has published on energy efficiency, sustainable energy and climate change. Her Energy Efficiency and Conservation Act, passed in May 2000, forms the framework for current policy on sustainable energy.

From 1980 until 1992 Jeanette taught in the Department of Planning at Auckland University, tutoring and lecturing in Environmental Studies and Energy Planning. During this time she published widely on the public policy aspects of energy and transport planning, management of hazardous substances, climate change, resource management and consumerism. She has also worked as a consultant for local authorities, regional councils and government departments on these issues, and worked with the government to develop the Land Transport Management Act.



**Bill Rosenberg** Economist and Director of Policy, Council of Trade Unions.

Bill Rosenberg was appointed Economist and Director of Policy at the CTU in May 2009. He holds a B.Com in Economics, a BSc in Mathematics and a PhD in Mathematical Psychology. Bill was previously Deputy Director, University Centre for Teaching and Learning at the University of Canterbury, a Member of the Institute of Directors, a Commissioner on TEC, and was a



member of the Regional Land Transport Committee of Environment Canterbury.

Bill Rosenberg is widely published on globalisation, trade and e-learning and has been an active trade unionist for 30 years including the Tramways Union and Association of University Staff where he was National President for several years.
